Motion was made by John Lewis and seconded by Steve Lowrance to approve the minutes from the previous meeting. Motion passed.

OLD BUSINESS

Chris Schleutler stated, concerning Lincoln Subdivision, that the city is going to furnish a camera to run in the drain line to check for any blockage.

NEW BUSINESS

1. John Lewis requested that a new bridge in the Hampton Community be named the E. C. Miller Bridge. The family will pay for the expenses. Motion by John Lewis and seconded by Steve Lowrance, motion passed.
2. John Lewis requested that Jack and Slim take a look at a ditch line on Warriors Lane. This was requested by Mrs. Norris.
3. Pierce Town Rd. problem is being put on next month's agenda.
4. Swimming Pool Rd.- John Lewis and Roy Livingston both requested speed bumps be installed on this road. Reckless driving and speeding has been observed on several occasions. Mr. Perkins stated that he can no longer install speed bumps. He said, it was passed by the County Commission under Roy Taylor's administration. Roy Livingston requested to see the minutes too see when this was passed. Mr. Ritchie is going to try to find out this information.
5. Sonja Culler told the committee that a dead end sign was needed to be installed on the John Taylor Rd. A request was made for this sign. Sonja made the motion and seconded by John Lewis to have the sign installed. Motion passed.
6. Richard Winters had a petition signed by over 140 people to name a bridge the Carroll Boone Bridge. The bridge is located on highway 143 going into Roan Mountain State Park. Family will pay for the expenses. Motion by Steve Lowrance and seconded by Sonja Culler. Motion passed.
7. Gebe Ritchie – the people in Roan Mountain wants 911 to change the name of their road from Vern Rd. to Vernon Rd. Motion by John Lewis and seconded by Steve Lowrance. Motion passed.
